#### Terms and Conditions

#### **OWNERSHIP RIGHTS AND RESPONSIBILITIES:**

Photographer and Client agree that unless stated otherwise in this document, Photographer owns any and all copy or reproduction rights. Client agrees to not reproduce or copy any digital images or other photographs of the event, taken by Photographer, without Photographer's written permission. Any unauthorized reproduction of digital images constitutes a breach of this agreement and will subject Client(s) to any and all applicable civil penalties. Digital Negatives, if provided, will include printing rights allowing reproduction of images for personal use. Restrictions are included on the printed label.

#### **RETAINER AND PAYMENT REQUIREMENTS:**

To reserve the event date, Prints Charming requires a non-refundable deposit of 1/3 of contract total. Photographer will not hold any date open without receipt of said retainer. Prints Charming must receive the remaining balance on the date of event. Checks returned for any reason will incur a \$60 fee. Any balance and all fees must be paid in full prior to delivery of items described in the package.

#### **PHOTOGRAPHER DISCLAIMER:**

Photographer agrees to return deposit to client in the event of nonperformance or non-delivery caused by Photographer. Client acknowledges that the technology used to photograph the event and the mediums in which events are recorded on are subject to mechanical failures and faulty mediums. In the event of non-delivery caused by such events Photographer and Client agree that Photographer is not responsible for any other damages, emotional or otherwise. Photographer is not responsible for inclement weather prohibiting outdoor photography. Any and all delays to event(s) by any person(s) in the bridal party, guests or family members may reduce the number of images shot. These delays will also reduce opportunities for photographer to capture any special requested poses and possibly standard poses.

#### **EXCLUSIVITY:**

Other persons may take photographs at the wedding and reception, however all "formal" or other posed shots set up by photographer are for photographer to photograph exclusively. Guests and family are not to use SLR or DSLR cameras to photograph poses set up by photographer. It is the Client's responsibility to inform all guests of said policies to eliminate any disruption of photography services.

#### **DELIVERABLES:**

Digital Negatives and/or DVD's shall be delivered within 6-10 weeks after date of event covered. Client is responsible for notifying Prints Charming upon receipt as to the level of satisfaction with products. Edited images will be available online for viewing, sharing and purchase once completed.

#### **PHOTO BOOK:**

Client is to select 50 images from their Digital Negatives that they would like to appear in their Photo Book(s). Selected image numbers are to be emailed to Prints Charming and then the Photo Book will be designed, ordered and shipped. Images included in layout of any and all Photo Books will be identical. If client desires different image selections for each Photo Book an additional fee of \$25 per Photo Book will apply for each Photo Book layout after the initial Photo Book layout. These additional fees must be received prior to order being placed. Tracking information will be emailed to client upon receipt.

#### **LIGHTING:**

Flash and off-camera flash photography will be utilized as photographer deems suitable. Photographer will follow "no flash" policies as directed by officiant and/or representative(s) at location of ceremony. All videography shall be done under existing lighting conditions.

#### **CANCELLATION:**

If the cancellation occurs within the thirty days prior to the event a charge of \$300.00 will be due or deducted from any payments before a refund is given.

#### **RESCHEDULING:**

If your event date changes from the one stated in this agreement you may reschedule to any other available date. In the event that Prints Charming is not available the cancellation policy above will be enacted. A new agreement must be signed with the new dates.
