\_\_\_\_\_ **MINORS**

Special laws apply while transporting passengers UNDER 21 YEARS OF AGE, Section 5384.1 and 5384.5 of the Public Utility Code. In brief, these laws require our drivers to ascertain identification. If any passengers are under 21 years of age, the driver must read a statement advising that

“NO ONE SHALL BE ALLOWED TO DRINK ANY ALCOHOLIC BEVERAGE WHILE MINORS ARE PRESENT. IF SO, OUR SERVICE WILL BE TERMINATED IMMEDIATELY. THE CUSTOMER AND PARTY WILL BE RETURNED TO THE POINT OF ORIGIN.

\_\_\_\_\_ **EXCESSIVE MESS \$50-\$100-** we provide you a trash bag to gather all trash at the end of your booking if there is excessive mess left there will be a fee.

\_\_\_\_\_ **SPILT DRINKS \$25-\$50**

If drinks are spilt there will be a fee for cleaning as the seats have to be removed for proper cleaning. There is electrical ran under seats and spilt drinks can cause major damage we highly recommend utilizing cup holders.

\_\_\_\_\_ **SMOKING**

If you are caught smoking in the vehicle, you will be charged a \$200.00 refresh fee and a \$400.00 fee for each burn in seats, carpet, headliner, or any other place in the vehicle.

\_\_\_\_\_ **VOMITING**

Vomiting in the vehicle will be a \$400.00 fee. This fee is necessary due to the costly cleaning and vehicle down time. The driver will gladly pull over when safe to do so.

We are not responsible for delays due to passengers being late, heavy traffic, accidents, missed flights, bad weather or any other natural disasters.

If I or anyone in my party should default on any of the above terms of conditions, the rental agreement will be terminated, By signing this contract I am agreeing that if anyone is injured under any circumstance, myself and any or all passengers boarding the bus can not hold U\$ Currency Entertainment LIABLE . There are no seat belts on the bus. All passengers ride at their own risk and carry full responsibility and liability for any injures that might occur on or off the bus. We are not responsible for any accidents, falls, or injuries and carries no responsibility or liability.
