



Memphis Riverboats, Inc. Event Contract

This proposal is valid only with the signature and title of an authorized MRB officer. Any portion or section of this agreement found to be unenforceable may be removed without effect on the remaining portions or sections.

Time is of the essence; this proposal expires in 10 days. This proposal does not grant a first right of refusal to Charter/Buy-Out; it is not a contract between Client and MRB until a signed offer and deposit by Charter are received by MRB. Booking is tentative and non-binding on Client or MRB until accepted by MRB and funds are verified. The proposal is subject to "MRB Guide" (June 20, 2005). Client warrants that they will read, understand and will comply with these materials. They are binding as if written here and are included by reference. Client is urged to read these materials carefully. Access to MRB facilities and vessels will be denied if obligations contained in "MRB Guide" are not met.

All products and services subject to 9.75% Tennessee State Sales tax. Alcohol prices include tax. Bar deposits are taxed as services until final bar charges are calculated. A 15% service charge is added to all tabs ran at the bar. **BAR TABS WILL BE PAID FOR ON THE DAY/NIGHT OF THE EVENT ON THE BOAT.** Please ensure a card is available at the end of your cruise for this option. Should you choose to do "Drink Tickets" for your guests, you must supply your own tickets. At no time will alcohol be provided to minors. This will result in the event ending. Due to MRB Liquor License, outside alcohol **WILL NOT** be permitted. If found, this will result in confiscation and/or termination.

Commitment fees and anticipated balance are earned by MRB when collected and apply to total charter price. Refunds are issued in accordance with "MRB Guidelines" (June 20, 2005). Payment for unanticipated balances may be required before the vessel leaves the dock. A 30% deposit is due at the time of booking; Final details must be made and the remaining balance is due 2 weeks prior to the event. If you have not paid for your event two weeks prior, we cannot guarantee that you will be able to make any changes to your event and you will also be charged a 10% late fee in addition to the amount that is due. Event Cancels and all paid fees and/or service charges are forfeited if balance is not paid by due date. All fees and/or service charges are **NON-REFUNDABLE**.

If you choose to have an event on an actual Holiday there will be a Service Fee added.
IF CHARTER IS SCHEDULED ON A FRIDAY OR SATURDAY NIGHT DURING THE HOURS OF 6PM - 10PM, MARCH – OCTOBER, CHARTER TOTAL MUST EQUAL THE SAME AMOUNT AS A CANCELLED DINNER CRUISE.

(ISLAND QUEEN- MUST EQUAL \$ 4500.00 before tax)

(MEMPHIS QUEEN III- MUST EQUAL \$6100.00 before tax)

By reserving a boat and making deposit payment for a Friday or Saturday night during March - October during 6pm - 10pm, you agree to pay the minimum amount or forfeit your deposit.

No more than 5 passengers may come on-board for decorating purposes when decorating time is purchased. If you do exceed the number of passengers paid for, you will be be charged for the additional passengers the day of or next business day. Every passenger on board must have a ticket including their own entertainment, decorators, infants, toddlers, etc. NO EXCEPTIONS! No glitter, confetti, or open flame will be allowed on the vessels. Any chair thrown overboard will result in a \$50 charge per chair.

All Third Party Sales MUST BE APPROVED by Memphis Riverboat, Inc. MRB has the right to void contracts that do not have permission to sell and mark-up ticket prices.
