




Food & Beverage

Guarantees

All banquet details must be submitted to the Catering Department at least ten business days prior to your event. Guaranteed attendance numbers will also be required at this time. This number is a guarantee and not subject to reduction. If a guarantee number is not provided, your agreed contracted amount will be assessed as your guarantee. In the event that your actual attendance exceeds your guarantee number on the day of the event, every effort will be made to duplicate your menu for the additional guests. In the event this cannot be done, a substitute will be provided at the original cost.

Taxes & Services Charges

All food and beverage options are subject to applicable service charges and tax as specified on the contract. Functions not meeting the minimum requirements are subject to a surcharge.




Outside Materials

Hilton Garden Inn shall not assume responsibility for damage or loss of personal property brought onto the premises or left in the hotel or banquet area. Please designate someone from your group to remove all personal items at the conclusion of your reception. Confetti and glitter are not permitted in the banquet area under any circumstance. Articles cannot be tacked, taped or fastened to walls, ceilings or fixtures. Please consult your Catering Representative for assistance with displaying your materials.
