#### **PAYMENT DEPOSIT & CANCELLATIONS**

Bear Creek requires a deposit of \$1000 upon booking your event. The deposit is applied against your final bill. The deposit is NON-refundable.

All prices quoted are subject to 5% GST. All additional food and beverage charges are subject to 18% Gratuity + GST.

A credit card is required to be put on file in order to book your event.

### AGLC LIQUOR REGULATIONS

All events must comply with the Alberta Gaming and Liquor Commission regulations. A summary of these regulations follow;

- Any guests caught providing minors with alcohol will be asked to remove themselves from the facility.
- Bear Creek staff will demand proof of age anytime a person appearing less than 25 years of age requests to be given any liquor or purchase liquor. Photograph identification must be presented upon request. Liquor will never be sold, provided to, or consumed by minors or intoxicated persons on the premises liquor cannot be provided or sold until after 10:00 am.
- Bear Creek staff reserves the right to refuse liquor service and remove individuals whose behavior becomes quarrelsome, riotous or disorderly, and/or is involved in illegal activities, such as drug dealing, ETC.
- Bear Creek reserves the right to ask intoxicated individuals to leave the property. We also hold the right to bar entry of individuals who have been removed from the premises repeatedly.
- Only liquor supplied by Bear Creek Golf Club is permitted on the premises. All liquor will be dispensed by Bear Creek staff and will not be available on a self-serve basis. Patrons are not permitted to bring their own alcoholic beverages onto the premises. All liquor containers will be opened by staff prior to being served to the customer. All liquor sold or provided may not be removed from the premises. Liquor may only be sold and/or dispensed from the Clubhouse, Event Centre, and Beverage carts.

#### FOOD REGULATIONS

All Food and Beverage charges are subject to a 18% gratuity charge + GST.

#### LIABILITIES

The Event host is responsible for the actions of all of its participants and guests and will compensate Bear Creek Golf Club for any losses due to damages or claims to the facility during their event.

PAL Insurance is required by the host in order to run your event. This should be completed online and a physical copy given to the events coordinator.

SETUP & TAKEDOWN
You will have 3 hours the day prior to your event for set up. All items must be removed prior to 10 am the following day (unless otherwise approved) Any extra time is subject to a \$50/hour fee

Standard setup of the room with tables and chairs, in house table linens, venue rent, bartenders, dishware on site, LCD projectors, TVs, AV equipment, PA system, microphone and podium.

OUTDOOR CEREMONY
Maximum time allowed for outdoor ceremonies is 20 minutes due to timing and safety issues with golfers. If the ceremony starts late or is over the alloted time, there will be a charge of \$250.00 for every 10 minutes. Due to saftey issues with golfers on the golf course, other areas of the golf course other than the ceremony site and Event Center are not available for pictures.
