

# Maple Ski Ridge Event Rental Terms & Condi ons

Effec ve Date: 6.5.2025

These Terms & Condi ons apply to all weddings and corporate events booked at Maple Ski Ridge. By reserving your event date, you agree to abide by the following policies. These terms help ensure a smooth, safe, and memorable event for you and your guests.

# 1. Reserva on & Payment

- A signed agreement and non-refundable deposit of 25% is required to secure your date.
- Final payment is due **30 days** before the event.
- Accepted payment methods: check, credit card, or ACH transfer.

### 2. Cancella on Policy

- All cancella ons must be submi ed in wri ng.
- Deposits are non-refundable.
- Cancella ons within **30 days** of the event require full payment of the rental fee.

#### 3. Venue Access

- Access is limited to the agreed rental window, including setup and breakdown.
- Addi onal hours must be pre-arranged and may incur extra charges.
- Early or late arrivals without approval may result in fees.

### 4. Capacity & Use

- The Lodge accommodates up to 150 guests.
- Outdoor areas can host events up to 4,000 guests (depending on setup).
- Client must follow all local noise ordinances and Maple Ski Ridge event guidelines.

# 5. Food, Beverage & Alcohol

- Clients may bring their own food or use an approved vendor.
- If alcohol is served, the client must obtain a temporary liquor license in accordance with NYS law.
- No glass containers allowed in outdoor areas.

# 6. Vendors

- All vendors must be pre-approved by Maple Ski Ridge.
- Vendors must provide proof of insurance.
- Setup and teardown must occur within the agreed rental period.

#### 7. Decora ons & Setup

- Use removable materials only. No nails, tacks, or permanent adhesives.
- No open flames, fireworks, gli er, or confe unless pre-approved.
- All decora ons and materials must be removed a er the event.

# 8. Cleaning & Damage

- Client is responsible for basic cleanup: removing décor, trash, and vendor equipment.
- A cleaning/damage fee of \$300 may be charged if excessive cleanup is required.
- A refundable security deposit may be required.



#### 9. Chairli & Transporta on

- Chairli is for uphill travel only. Guests cannot ride it down.
- Chairli rides are an addi onal \$3200.
- Return downhill will be on foot, on designated walking trails unless otherwise arranged in advance.
- Allow extra me for guest movement to/from the summit.

#### 10. Weather & Outdoor Events

- Events are held rain or shine.
- Client is responsible for tents or alternate weather plans.
- No refunds issued for weather-related changes or cancella ons.

# 11. Liability & Insurance

- Client is responsible for the conduct of all guests and vendors.
- Maple Ski Ridge is not responsible for personal injury, property damage, or the .
- Event liability insurance is strongly recommended and may be required.

#### 12. General Policies

- No smoking inside any buildings.
- Pets are not allowed unless approved in advance or are service animals.
- Children must be supervised at all mes.
