

Wedding Agreement

Agreement for Wedding Photography

This agreement entered into on _____ is between Studio Four, Inc. in the state of Florida and doing business as Studio Four Photography (hereinafter "Studio Four") and the undersigned (hereinafter "Client") relating to the wedding of :

Service Coverage

PACKAGE SELECTED: \$999 Special

The parties agree that Studio Four will furnish in the services of a photographer, _____, for photographic event coverage beginning at _____ until the conclusion of the event or for a maximum period of _____ hours, whichever is less. Additional hours will be billed at \$250 per hour. Studio Four will be the sole professional still photographer employed for the wedding day. Simultaneous photographic coverage by another professional photographer (excluding video), releases Studio Four from this agreement and immediately terminates service coverage.

Payment Policy & Expenses

A full payment of \$999 and any additional hour cost, is paid to reserve the date for the service coverage specified above. An additional 6.5% Florida sales tax will be added to the invoice.

Non-payment of any fees described above releases Studio Four from any and all obligations defined in this agreement.

Product Pricing

Studio Four warrants that all prices quoted for professional services, photographs and albums are valid for a period of three months following the date of the wedding. Orders placed after this period are billed at the studio's current pricing, which may be greater.

If the original wedding date should change, there will be an additional rescheduling fee of \$250.

On signing of this agreement by both parties hereto, the Studio will reserve the time agreed upon and will not make another reservation for the specified time frame. For this reason, all deposits are non-refundable even if the date is changed or if the wedding becomes cancelled for any reason.

Limitation of Liability

While every reasonable effort will be made to produce and deliver outstanding photographs on the wedding events, Studio Four's entire liability to Client for any claim, loss, or injury arising from the photographer's performance is limited to a refund to Client of fees paid. Because this is an uncontrolled event, Studio Four cannot guarantee delivery of any specifically requested image(s). In the unlikely event of personal illness or other circumstances beyond the control of the photographer, a substitute photographer from the Studio Four team may be dispatched to fulfill the obligations of photography herein contracted.

Review and Selection

Original images of the wedding are the property of Studio Four. Images will be presented to the client for viewing usually within three weeks of the event. These images are protected by Federal Copyright Laws (see below). A high resolution copy of the mages will be provided to Client once the storybook/ print order is delivered with release authorization for reproduction.

Album Orders

Studio Four will propose and advise in the layout of album(s), however, all choices by the Client prevail. Album orders will include choice of photographs selected (with specific instructions, if any) and these

decisions are made following inspection of images. A total of two album design sessions are included with the retainer fee. Additional album design sessions are billed at additional computer design fees. Due to the custom nature of album orders, all orders are final upon approval.

Ownership of Images

Studio Four owns all copyrights for any and all images produced in connection with this agreement. The parties agree that Studio Four may reproduce, publish or exhibit a judicious selection of such photographs as samples of photographic work to be shown to prospective clients and for instructional purposes consistent with the highest standards of taste and judgement. Client agrees to hold Studio Four harmless against any and all claims arising from any published images.
