Sagebrush Video Productions agrees to provide video production services in exchange for indicated fees to be **paid in full fourteen (14) days prior to event** to be taped. The final, finished wedding video will be ready 10 to 12 weeks from the date of the wedding providing client has delivered all necessary materials for inclusion to Sagebrush Video Productions on or before the deadline specified by Sagebrush Video Productions, which **includes this contract**. Client may either come to Sagebrush Video Productions to pick up their wedding video or Sagebrush Video Productions will mail it to an address specified by the bride and groom. Rush delivery and shipping to an address different than the shipping address specified in this contract are additional and must be paid in full prior to shipment.

Graphics Information Deadline:

To ensure prompt delivery of client's wedding video, any and all graphics information must be received by Sagebrush Video Productions on or before _____ (14 days before the wedding) . Graphics information includes but is not limited to: program, invitation, directions, map, and this video contract. For each day any necessary information is late in reaching Sagebrush Video Productions, client's wedding video may be delayed by another day and Sagebrush Video Productions will be held harmless.

Priority: *Sagebrush Video Productions is the priority videographer and will have the first choice of camera locations. Other people with video and/or still cameras may not use lights or wireless microphones without the consent of Sagebrush Video Productions. Other people with video and/or still cameras may not interfere with Sagebrush Video Productions' crew and will be instructed by client not to be in Sagebrush Video Productions' camera views. Client agrees not to make changes to agreed upon camera locations, ambient lighting, people or materials that may interfere with Sagebrush Video Productions' camera view, audio, lighting, etc. without the consent of Sagebrush Video Productions.*

Home Video: *Client is hiring Sagebrush Video Productions to produce a video for private, home use. Sagebrush Video Productions is the sole owner of the copyright and reserves all rights. Unauthorized copying of the video is prohibited by law and any additional uses of the video, such as broadcasting, cable casting, webcasting or any use of the video that may result in revenue, must have the explicit written consent of Sagebrush Video Productions. Because Sagebrush Video Productions professionally produces your wedding video and is the sole owner of the copyright, unauthorized submissions of any portion of said wedding video to television shows such as but not limited to "America's Funniest Home Videos" are in violation of United States Copyright Law. Penalties for copyright infringement can be as much as \$10,000 and one year in prison.*

Client indemnifies and holds Sagebrush Video Productions harmless for any potential violation of rights of participants when video is shown. If, for some reason, there is a member of the wedding party that does not want to be included in the wedding video, it is the responsibility of the client to notify Sagebrush Video Productions before taping begins.

Rights: *Client warrants that he/she has the legal rights to anything Sagebrush Video Productions will videotape, including photos, audio CDs, video tapes and DVDs, or any other elements delivered to Sagebrush Video Productions for inclusion in client's wedding video. Client agrees to indemnify and hold Sagebrush Video Productions harmless for any loss, damage, or liability for infringement of any rights arising from the use or sale of video client hires Sagebrush Video Productions to produce, edit, or duplicate.*

Cancellations: *In the event of the cancellation of your wedding both the bride and groom must notify Sagebrush Video Productions in writing. All deposits and/or monies paid to Sagebrush Video Productions are non-refundable. If postponement of your wedding becomes necessary, Sagebrush Video Productions will cover your wedding provided the new date is available. Should the new date be unavailable, all deposits and/or monies paid to Sagebrush Video Productions are non-refundable.*

Limitations of liability: *Sagebrush Video Productions will take the utmost care in providing services and handling client materials with respect to the video we produce. Sagebrush Video Productions may only be held liable, for any reason, for the return of any deposits paid. We agree that Sagebrush Video Productions shall not be held liable for losses due to causes beyond Sagebrush Video Productions' control and understand that Sagebrush Video Productions reserves the right not to return deposits for such things including, but not limited to, a minister disallowing videotaping at the last minute, electrical power failure, equipment failure, failure of the client to provide adequate lighting or other matters such as bad weather, traffic jam, the United States Postal Service, or a labor strike.*

Meals: *If Sagebrush Video Productions is with you during meal periods and accommodations for food are not provided by the client, Sagebrush Video Productions will leave for a one hour meal break.*

Sagebrush Video Use of Video:

Sagebrush Video Productions reserves the right to use any part of the video we shoot for demonstration tapes, display, contest entries, or any other lawful purpose, including nationally broadcast television programs. Sagebrush Video Productions is the legal owner of all video footage, camera original and edited, and will keep all camera originals and edited masters.

Payment Terms: *A non-refundable deposit of fifty percent (50%) of charges is required to reserve a date. The balance is payable fourteen (14) days prior to the event. Personal checks, cash, money orders, and Paypal are accepted. If payment is deemed uncollectible or not received by the date specified in this contract, Sagebrush Video Productions may void said contract and all monies paid to Sagebrush Video Productions are non-refundable. No video, either in progress or completed, may be taken off studio premises unless balance due for same is paid in full.*

Overtime: *In the event that Sagebrush Video Productions is required to stay longer than the time indicated in this video contract, overtime fees will be incurred. Overtime is charged at the rate of \$250.00 per hour. It will be invoiced the first business day following your wedding and will be due ten (10) days from the date of your wedding. Editing will not begin until overtime charges are paid in full.*

Sales Tax: *The State of Kansas requires destination sales tax be added to video production products and services delivered within the State of Kansas. There is no charge for sales tax on video production products and services delivered out-of-state.*

Adjustments: *Any claims for adjustments in connection with services or materials provided by Sagebrush Video Productions must be received by Sagebrush Video Productions in writing within five (5) business days from the date of service or the date final DVDs are received, otherwise client has waived all claims.*
